20/06 Pavilion

- Councillors' Community Grant the form for the grant application was signed by Martyn.
- Micro-grant for fridge no response received from EALC since the application. Debbie will follow up.
- Pavilion hire use of music councillors had no objection to the use of background music for one booking in 2020.

20/07 Playing Field

- Play equipment inspection the report was circulated prior to the meeting. It was
 noted there were no areas of "high risk" to consider. One item to consider was the
 expansion of the surface area underneath the swings. It was agreed to reconsider this
 item at the March meeting.
- Playing field entrance gates A parishioner had approached the parish council re replacing the entrance gates and some fencing. It was agreed to discuss this item further at the March meeting. It was noted that grant funding would probably be needed.

20/08 Highways

There was water running over the road at the junction of Birdbrook Road/Cornish Hall End Road, possibly as a result of ditch infill from Gigaclear works. This will be reported into ECC Highways.

- Footbridge on path no 13 at junction with footpath 21 (image no 11 0842) will be reported to ECC.
- Footbridge on path no 13 (image no 11 0923) overgrown bridge will be reported to ECC
- Footpath 24 overgrown hedge the landowner has been approached to trim the hedge but has declined. Will be passed to ECC.
- Stiles thought to be footpaths 5 or 29 (to be confirmed) although the stiles have been chewed by livestock they appear to be sound.
