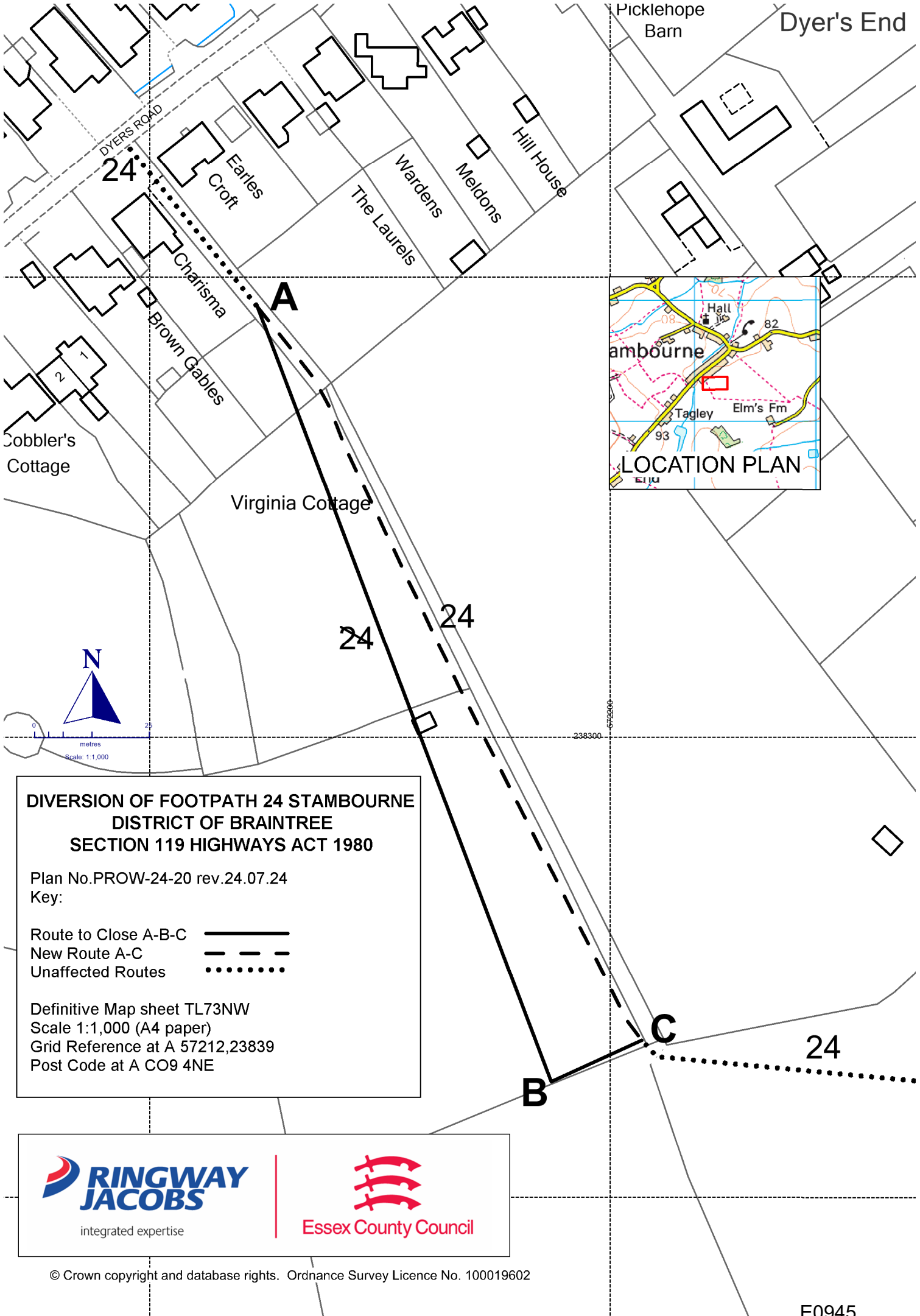
This Order is made by Essex County Council (“the authority”) under section 119 of the Highways Act 1980 (“the 1980 Act”) because it appears to the authority that in the interest of the owner of the land crossed by the footpath described in paragraph 1 of this order it is expedient that the line of the path should be diverted.

The landowner has agreed to defray any compensation which becomes payable in consequence of the coming into force of this order and any expenses incurred in the order making and bringing the new site of the path into a fit condition for use by the public.

Braintree District Council have been consulted as required by section 120(2) of the 1980 Act.

BY THIS ORDER:

- 1) The public right of way over the land situated south of Dyers Road known as Footpath 24 Stambourne in the District of Braintree and shown by a bold continuous line on the order map numbered PROW-24-20 rev.24.07.24 contained in this order and described in Part 1 of the Schedule to this order shall be stopped up after 35 days from the date of confirmation of this order.
  
- 2) There shall at the end of 28 days from the date of confirmation of this order be a public footpath over land situated south of Dyers Road known as Footpath 24 Stambourne in the District of Braintree as described in Part 2 of the Schedule and shown by a bold broken line on the order map numbered PROW-24-20 rev.24.07.24 contained in this order.

## SCHEDULE

### (PART 1)

#### DESCRIPTION OF SITE OF EXISTING PATH OR WAY

A part length of Footpath 24 Stambourne of unknown width shown by a bold continuous line on the order map commencing from point **A** at grid reference 57212,23839 located on a path between property boundaries running in a south easterly direction across a garden and through a paddock for a distance of approximately 179 metres to point **B** at grid reference 57218,23822 located approximately 21 metres from the south west corner of the field running in a north easterly direction within a paddock for a final distance of approximately 21 metres to point **C** at grid reference 57220,23823 at a field boundary where it continues unaffected.

### (PART 2)

#### DESCRIPTION OF SITE OF NEW PATH OR WAY

A footpath of variable width being between 1.8 and 2 metres in width shown by a bold broken line on the order map commencing at the aforementioned point **A** running in a generally south easterly direction alongside a paddock for a total distance of approximately 180 metres to the aforementioned point **C** where it continues unaffected.
